INCORPORATING YOUR BUSINESS IN AUSTRALIA

A business name is a name or title under which a person, or other legal entity, carries on business. It also helps customers and other businesses find, identify and connect with your business.

You need to register a business name if you conduct business under a name other than your own.

Registering Your Business

When you register a business name, you register it nationally with ASIC, the governing body under Australian Government. This means you can operate your business in any state or territory in Australia

Information/Documents Requirement

- name and contact details of the applicant
- details of each person or organization associated with the business (e.g. partner, director, secretary or shareholder) along with copies of national IDs
- proposed company name
- place and date of birth for directors and any secretaries (must be at least 18 years of age)
- local address of business (taken care by us)
- registered agent with a local Australian address (taken care by us)

Company Registration

To set up a company, it must be registered under the *Corporations Act 2001*. You can register these types of companies here:

- Proprietary limited companies (also known as private companies) the most common company structure used by small businesses
- Public companies limited by shares or guarantee
